RESPONSIBILITIES:

1. The safety of a yacht and its crew is the sole and full responsibility of the owner. The owner must ascertain and ensure, insofar as possible, the shape and sea-worthiness of the boat, its rigging, equipment and sails, and that all required safety equipment is **on board** and in operating condition and that the crew knows the location of the equipment and how to use it.
2. The owner must ensure that his boat meets the minimum requirements of the Canadian Coast Guard for on-board safety equipment at all times and **Must Pass a Coast Guard courtesy inspection by June 30, 2024 in order to be eligible to race.** Points will not count after June 30, 2024 if not passed and will result in being DSQ for each race until done.
3. It is the **sole and full responsibility** of the owner to determine whether or not to start and or to continue to race.
4. The owner must have a paid-up insurance policy providing a **minimum \$1,000,000.00 of liability coverage.** **Proof of insurance must accompany the registration.**
5. Paid-up Yacht Club dues for 2023 for each owner & skipper/helmsman.

If assistance is provided to any participants by committee vessels, personnel or another vessel, it is at the risk of these participants.

I hereby agree to all of the above-stated conditions as well as any additional rules, regulations and instructions as issued by The Shediac Bay Yacht Racing Association.
